Dear Friends,

Cathedral Square's dedication and teamwork continues to positively impact a growing number of Vermont elders. This past year has offered many examples of how our efforts, alongside those of our partners, make a difference throughout many Vermont communities.

We were told many times during this particularly challenging winter that our properties had the safest sidewalks and grounds around. This was no surprise as our maintenance team works diligently to ensure residents in all 27 communities have a secure and comfortable home. We are proud to report this commitment has resulted in two scores of 100 on our HUD inspections and 97 or higher on all others completed this year. Such perfect scores are rarely, if ever, awarded.

In the fall of 2013, we opened Thayer II in Burlington's New North End. This thoughtfully designed building quickly became home to 36 Vermont elders. A special thanks to The Harry and Jeanette Weinberg Foundation for providing the final funding source essential to making Thayer House II possible. At the time of Thayer II's opening, our wait-list rose to over 760, indicating a definitive need for more affordable elderly housing in Vermont. In an ongoing effort to meet this need, Cathedral Square will open the Wright House in Shelburne this summer. The Wright House will offer 36 additional homes and bring the number of Cathedral Square residents to over 1,100.

Cathedral Square's Support And Services at Home (SASH) initiative is growing faster than ever. SASH currently has over 3,100 participants and has expanded from one pilot site in 2010 to 115 sites as of April 2014. Participants include those living at SASH sites as well as out in communities throughout Vermont. SASH Coordinators and Wellness Nurses work together with our community provider partners to keep up with the significant need Vermont elders, and those with disabilities, have for our services. HIGHLIGHTS FROM 2013



A groundbreaking celebration for Wright House was held in **June 2013.** This new development will feature many green and sustainable features including a green roof, solar photovoltaic system, a rainwater collection system, and a digital dashboard in the lobby which will post energy use and renewable energy production.



Our volunteer program grew 23.5% last year. We now have 257 dedicated volunteers who worked 9,596 hours just in the past year. In 2013 our meal programs at Grand Way Commons, Town Meadow and Whitcomb Woods served almost 2,000 meals, totaling over 1,700 volunteer hours for our three meal programs.



CSC entered into a partnership with Housing Vermont on the planned preservation and rehabilitation of Kelley's Field senior housing in Hinesburg. Anticipated start of construction is November 2014.



Thayer House Phase II was completed. 36 new apartments were added to phase I for a combined total of 69 senior apartments in a multi-generational, mixed income neighborhood in Burlington's new north end. The demand for Thayer House was incredible, the property leased up within the first 28 minutes of receiving applications.

CSC was pleased to obtain **Green Certifications at Thayer** House from Energy Star 3.0 and **Enterprise Green Communities.**



Cathedral Square will partner with Eric Farrell & Champlain Housing Trust in the Master Plan development of the Burlington College campus to include a proposed **74 unit senior** housing property.

Cathedral Square was awarded a Green Grant from Enterprise **Community Partners** to work on greening our portfolio. This work will be accomplished over the next two years.



SASH is operating at 94 affordable housing locations across the state. 22 non-profit housing organizations are participating including nine public housing authorities, six community land trusts, and seven other housing nonprofits. **SASH** is making a difference:

- SASH reduced the number of people reporting 3 or more falls down 39% statewide in 2012 to 29% in 2013.
- SASH reduced the number of participants at High Nutritional Risk from 35% to 24% over the same period.






